The organization is working exclusively for the developmental aspects of the poor people and partners with governments to design policies and programs in India. **Arunodaya Trust** an affiliate of Holland which is a well established worldwide. It is a Social Development organization dedicated to improving the lives of the Children, Youth and Families living in below poverty line. In India, **Arunodaya Trust** has started its activities in 2008. At present **Arunodaya Trust** is operating a good number of activities in jerkwater villages, tribal habitations and slums. **ArunodayaTrust** Developmental Activities are widely spread in 2 States. The outreach of the organizations is extensively wide and offers its services to very remote and under developed areas of the Telugu speaking states. At present, the organization is working in the tribal areas to improve their livelihoods, market linkages and product development skills. **Arunodaya Trust** assists the tribes and marginalized people to develop indigenous technology and acts as catalyst for implementing a few interventions to improve Economic Conditions.

It works towards social change and development through integration of public and private convergence to crack the vicious cycle of poverty and social isolation and to restore hope.

- A few well-known illustrations, the organization carried out are formation of **Arunodaya Trust** (Human rights awareness and empowerment of marginalized especially for Scheduled tribes and Scheduled Castes and minorities)
- Formation of Child Rights Advocacy Foundation (**CRAF**) in the schools and special emphasis is given for the families belonging to Scheduled tribes, Scheduled Castes and minorities.
- Initiation of **National Juvenile Justice Desk with the help of Don Bosco**
- Established and supported **Child Safety Net** to control the child abuse and exploitation.
- Formed 12 MACS in 5 Districts and the Rate of Disbursement (2 Cr) to Rate of Recovery is **1:0.91. The rate of Interest is 25 paisa.**

Arunodaya Trust has involved in a good number of activities that are related to expression of voice of the Scheduled tribes. Scheduled Castes and minorities but also it immensely involved in the activities that are related to augment the house hold economic status and polity. It has built the capacities of the scheduled caste women and tribal women and developed the technology based skills in the youth. **Arunodaya Trust** has placed the trained youth in different private and public organizations. It assisted the Scheduled Tribe, Scheduled caste and Minority communities for Livelihood security, Primary Education and Health Education through participatory techniques.



Arunodaya Trust is neutral, impartial, independent, and not linked to any political party or governmental body. The Organizational personnel and staff teams provide assistance to youth, street children, marginalized women and people in need, irrespective of their nationality, race, caste or religion. **Arunodaya Trust** supports the works of a large number of Community Based Organizations of the regions in 1)Health and Nutrition, 2) Water and Sanitation 3) Child

Growth and career Development, 4) Youth development and technical Skill augmentation, 4) Women empowerment and Livelihoods and finally Human Rights for poor and marginalized communities. **Arunodaya Trust's** team of professionals includes Project management, Training and capacity building, Research, policy and finance staff **Arunodaya Trust's** activities focus mainly on **promoting and securing the conducive rights based approach to access to improved Socio – Economical empowerment** for many poor people's betterment through direct services and millions more were influenced by the works. This includes

significant inputs of research, documentation, advocacy, networking and supporting NGOs. The Organization is working at national level, especially in Telangana and Andhra Pradesh states focusing on marginalized women, street children and youth and their families.

The core competence lies in facilitating community development programs through which susceptible women, Scheduled tribes, Scheduled Castes and Minorities and helpless youth's potential is realized and their rights, dignity, interests and skills are promoted. The range of interventions and activities of **Arunodaya Trust** covers the thematic supportive fields like Research and Consultancy, Trainings, Monitoring and Evaluation, Project appraisals, agency Performance assessment, Documentation and Impact measurement. The organization founded by social and philanthropic scientists with global experience, is managed by a young, enthusiastic and creative team whose envisage is to provide thorough counsel and capacity building backed by extensive analytical research. The Organization's expertise lies in applying simple and innovative approaches to find solutions for complex social problems. The very strength of the organization is scrupulous planning and pragmatic achievement of the set goals within the time line.

Arunodaya Trust Has been engaging in promoting a good number of developmental activities for bringing impact in the lives of tribes, poor and marginalized, street children and youth, It has created a favorable environment for voluntary actions in the State for more than two decades. The organization has coordinated State level Campaigns on RTI, Human Rights, Child Rights, RTE, NREGA, and Governance and Accountability etc.

The five distinct features of the organization being, 1) a strong project orientation, 2) high standards of quality in project management, 3) Activity based scheduling and time management and 4) Research and Impact assessment finally 5) remodeling according to the lesson learnt. Everything the organization does to create and maintain a friendly, informal growth and performance oriented work Implementation. The organization is engaged in research, training and consultation on various aspects of organizational development, including, strategy, structure, monitoring, evaluation, impact assessment. NGO performance and capacity mapping, Survey studies, organizational culture, restructuring of HR, change management and organization behavior etc.

The main functional areas of the Arunodaya Trust are

Skill Training and development for youth

Arunodaya Trust is lucky to find a good Academic institution to admit our kids in the middle of the academic year. It is an institution working on an alternative approach to education and it provides special attention for dropout, unskilled, semiskilled youth children. During the year the trust has introduced Computer training and Embroidery works to train the poor and marginalized women at neighboring slums. **Arunodaya Trust** conducts short-term courses of 2-3 months duration, often residential in naturopathy, focusing on young men and women from rural areas and urban slums. The model is based on strong industry linkages and youth counseling, and focuses on hands-on skills training. Courses taught include Self employed tailoring and embroidery, Computers and soft skills. In addition to industry specific skills, students also learn Basic English, computer literacy and life skills. **Arunodaya Trust** has a four-step mechanism which includes mobilization from source, training,

placement in jobs or entrepreneurship, and post-placement support. The primary objective of this program is 89

to create employment opportunities for disadvantaged adolescent girls in rural areas or women



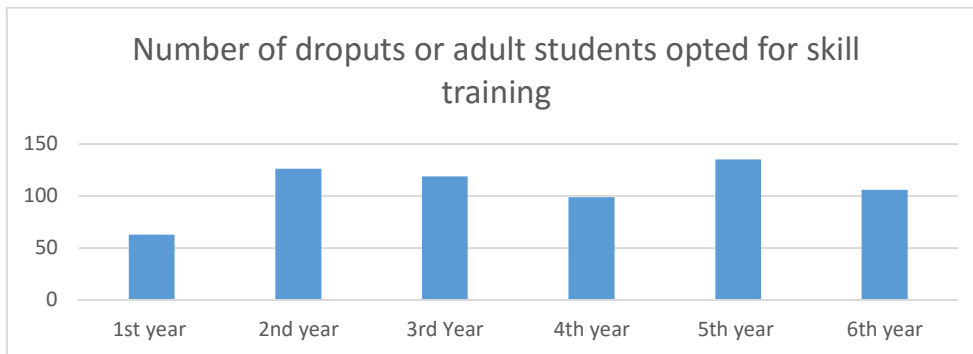
widowed at an early age by providing training in tailoring skills and a sewing machine.

- Till now 729 children has opted for formal education and 648 for vocational training.
- This year around 225 Girls are going to local schools at Hyderabad and 190 children are undergoing training at Non-formal technical school in 6 places.

- Trained more than 1200 women



- 100% are self employed and more than 500 women are linked with Financial Institutions
- 75% of them belong to Marginal castes and Below Poverty Line
- 100% of trainees are given soft skills and computer basics.

Vocational Skill Development center

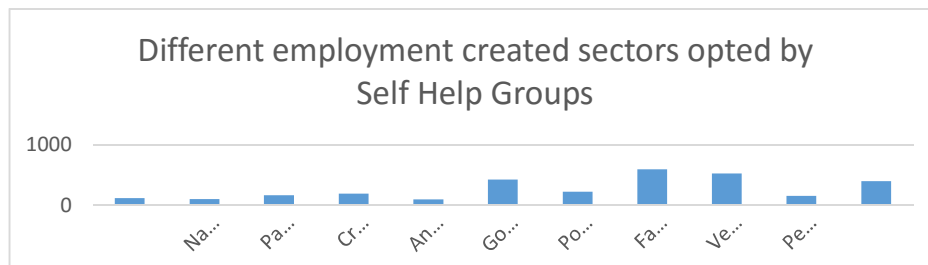

Entrepreneurial development

Arunodaya Trust has made a name for itself with the 'direct impact' innovations it has helped nature and implement in the areas of renewable energy, waste management, employability, livelihood and healthcare. Driven by the desire to bridge the gaps that keep social enterprises from reaching their potential, Arunodaya Trust provides entrepreneurs with access to technology, mentorship, investors, government agencies, local partners and business development support. The organization does not provide funding, but does offer social entrepreneurs with access to networks of experts, CSR foundations, pro-bono experts, B-school students, corporate volunteers, impact investors as well as other incubators and accelerators. So a suitable environment has been created for growth of women entrepreneurs. Because of the importance of women entrepreneurs, a number of institutions have emerged for growth of women entrepreneurs. The primary objective of this organization is to empower women entrepreneurs in rural sector. The primary objective of this organization is to empower women entrepreneurs in rural sector.

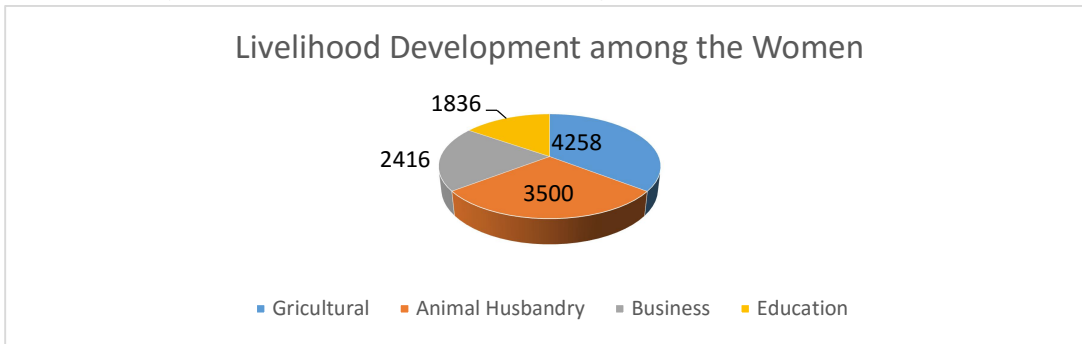
Livelihood

The Organization works to bring about positive changes in the actions of individuals, communities and institutions that improve the income levels in the house hold and well-being of vulnerable populations across the operational areas of **Arunodaya Trust**. The activities carried out with respect to Livelihood development are in close coordination with the issues and involve domain specific

expertise to bring out the best opportunities for growth. Arunodaya Trust ensures income generations by its reinforced services and capacities which are not only improved economical growth but also built enhanced service delivery mechanism. Thus the beneficiaries have become independently strong as far as resource mobilization unit or entrepreneurial skill is concerned.

The Activities carried out with respect to Livelihood

- ✿ Organization formed 24 MACS with around 12000 women. They were trained and assisted effectively for better livelihoods.
- ✿ The members of the MACS who got benefit in 2015 for Agricultural purposes are 4258
- ✿ The members of the MACS who got benefit in 2015 for Animal husbandry purpose are 3500
- ✿ The members of the MACS who got benefit in 2015 for Business purpose are 2416

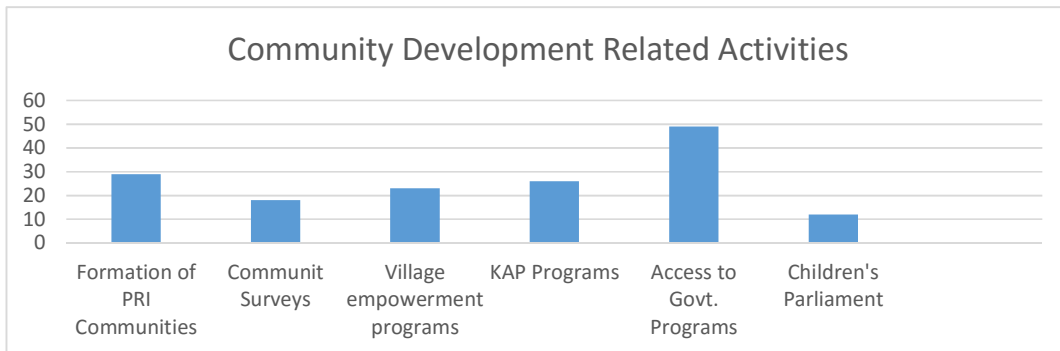

Women organized in self-help groups, strengthened in their capacity to act as agents change, have been engaging as primary movers in community development action. 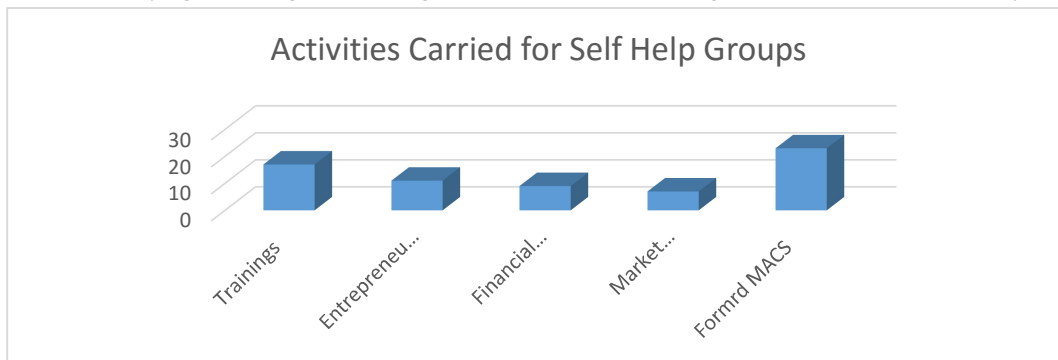
forward with the joint participation of the principal governance stakeholders active at the local level – the community, led by female leaders organized in to self-help groups, service providers from a

Main streaming Street Children



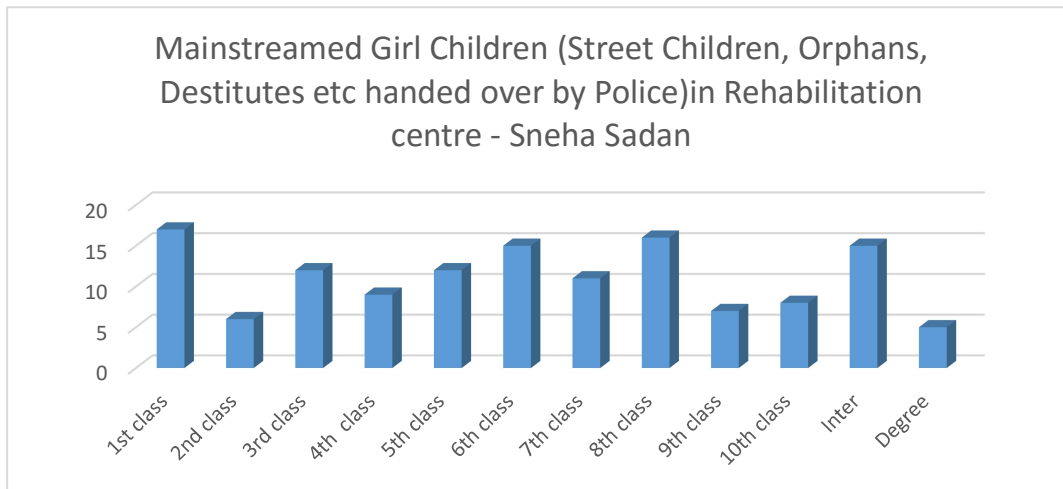
Children run away or are forced to leave homes where they suffer poverty, violence, abuse and neglect. They find themselves living on the streets because there is nowhere else to go and nobody to turn to. Arunodaya Trust works to



reach children as soon as they arrive on the streets and intervene before an abuser can. Every year thousands of children across the Telugu speaking states run away or are forced to leave homes that have become unbearable through poverty, abuse, violence and neglect. Reaching a child as soon as possible is crucial to getting to children on the streets before an abuser can, and before they become entrenched in street life. The organization races to get to children before the streets get to them. One of our core focuses apart from working on the ground is Advocacy and influencing policy. We believe that unless we continuously work with Government, National and International bodies to raise issues that need resolution or policies that need change, our work will not be complete.

- Arunodaya Trust runs a rehabilitation center for Street children, orphans, destitute and Child labor identified by child welfare committee and police

- Till date 8450 children and their parents or guardians are counseled and reunited with their families
- At present 133 children are with rehabilitation centre
- Free accommodation and food is provided
- Free counseling and free education is provided (133 children are in schools or in colleges).
- Conducts career and counseling campaigns (5 campaigns) in every year.



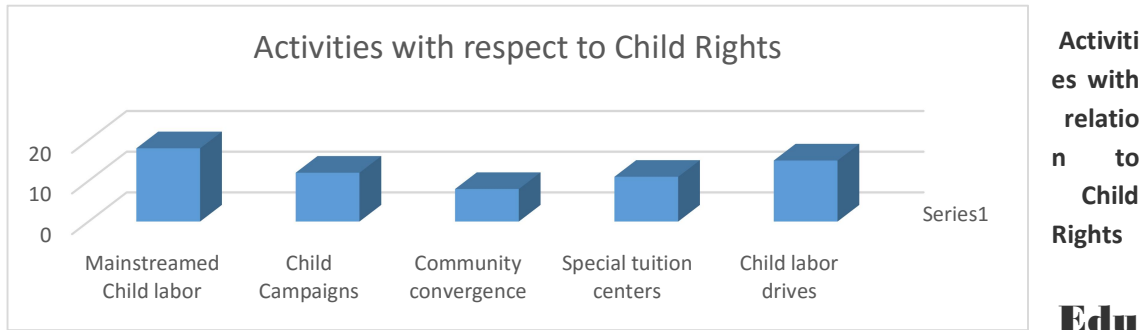
Child Rights

Arunodaya Trust works for extremely deprived children, Child labor, and trafficked and juvenile drug addicts. **Arunodaya Trust** believes that adequate support and guidance are the most powerful tools to protect children from exploitation and abuse. Working with teachers, parents, communities, employers and policy makers have curtailed the Child exploitation. The Organization has strengthened the child centered Community programs starting from the early 1993. The Organization has promoted idea and it organization's principal aim too that child protection could be achieved effectively in the family, school and community and at where the children live, by weaving safety nets, such as child-friendly schools and spaces, removing abuse and violence from families, preventing child labor, creating mechanisms for stopping child trafficking.

It presented a good number of International seminars with respect to Girl Child Education.

Health

Arunodaya Trust works to bring about positive changes in the actions of individuals, communities and institutions that improve the health and well-being of vulnerable populations across the state. The organization is dedicated to health and humanitarian aid activities in the communities. **Arunodaya Trust** committed to preventing disease, improving community health, and promoting sustainable development. It follows global health Norms (Health in MDG). The organization's Task Order focuses on institutional strengthening for Social and Behavior Change Communication (SBCC) at national and state levels. It mainly works in the areas of HIV/ AIDS, Vector Borne Diseases and Control, Water Borne Diseases and transmission Diseases. **Arunodaya Trust** takes active part to improve the health and well-being of people in the poorest communities and to improve capability in the Indian health system by engaging national and state structures by sharing our expertise in sexual and reproductive health, transforming the quality of health care and access to assert their rights for healthier lives

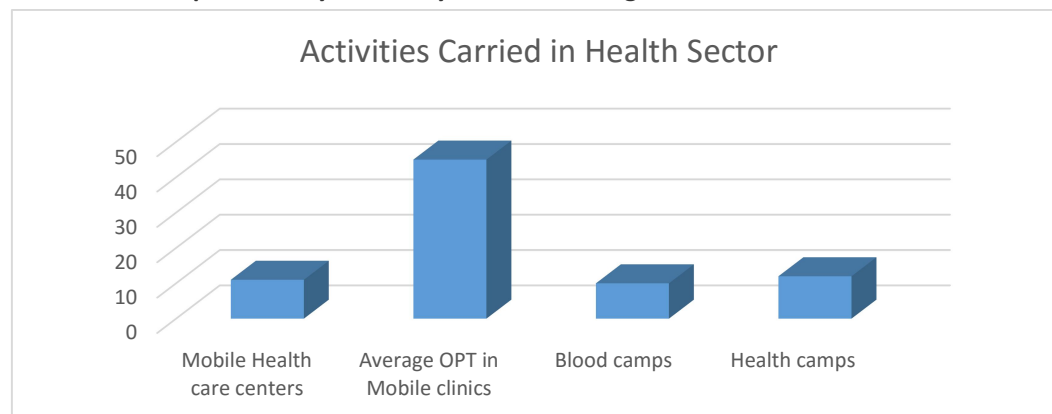

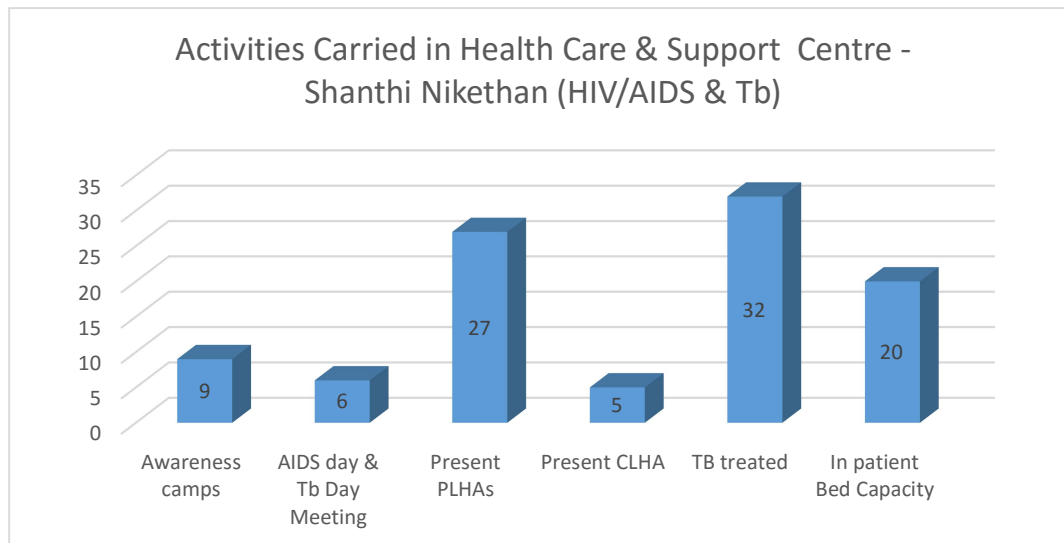

action on every front of the regional HIV response through its membership base, scientific authority and convening power. It advocates and drives urgent action to reduce the impact of HIV. The organization is also the steward of the district level workshops while implementing APSACS Project. The main focus of the organization is to provide institutional care homes for the PLHA, CLHA and children abandoned and orphaned by HIV/AIDS children of sex workers, truck drivers and children who have been abused and belong to poor socio economic conditions.. As on today the organization is able to reach up to 800 such needy children. Arunodaya Trust provides evidence-based, technical support to Department of health at district level to help them scale up treatment, care and prevention services as well as drugs and diagnostics supply to ensure a comprehensive and sustainable response to HIV/AIDS. It's goal is to build a better, healthier future for people.

Activities carried out are

- Every year 9 awareness camps are conducted in community halls at Block level. It covers 20 – 30 villages
- 8910 are counseled till date
- 198 infected have gone through ART and Nutritional Support (present 27 are there)
- 20 bedded In patient facility is available
- 5 are CLHA
- 24 hours care and support and referrals (ambulance and other emergency supportive equipments are present)
- World's Aids Day and World Tb Day meetings (4) held with Dept. of Health and Dept of Women and Child Welfare, Govt. of Telangana/ Andhra Pradesh.



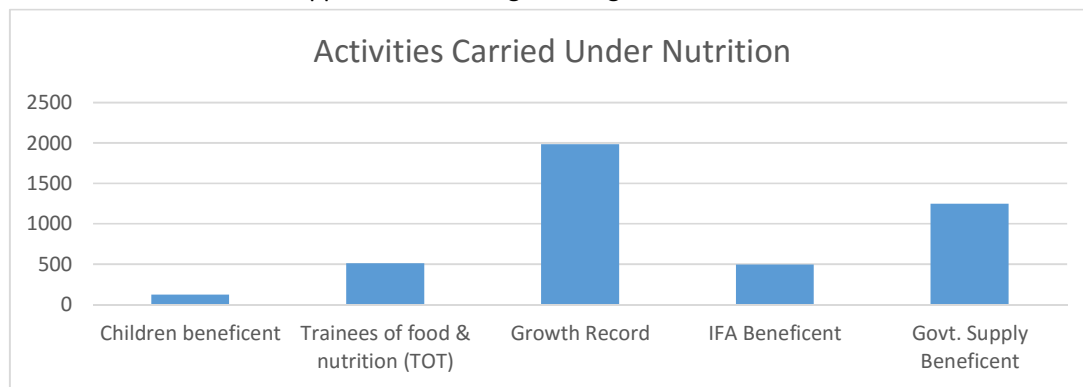
Nutrition

Arunodaya Trust has felt that the malnutrition is being a health problem before, but at present the malnutrition has become one of the social issues. Rooted in a myriad of social, economic and cultural causes, child / adult malnutrition cannot be solved via a mere clinical solution. Henceforth Arunodaya Trust followed a multi-pronged approach, where multi-disciplinary teams of doctors, nurses, nutritionists and social scientists work along with key caregivers, mainly mothers and other women, to address the determinants of child malnutrition, disease and death. **Arunodaya Trust** sought to improve mother and child health by tackling the vicious cycle of malnutrition and infection to address its root causes, such as poverty, powerlessness, low status of women, illiteracy, and inadequate health and sanitation practices. The Organization is moving beyond the realms of nutrition and health alone to embrace the child protection and education as well with the objective of providing a comprehensive package of gender equity-centered services.



The Activities carried out with respect to Nutrition

- Food Supplements given to Severe Acute Malnutrition Children (126) through Mobile Medical Camps
- 24 workshops and Trainings carried to identify and to cook locally available nutritional rich vegetables and other eatables (513 participants in 24 trainings).
- Weight and growth records maintained for every in Mobile clinics (1985 beneficiaries till date)
- Special Care has been taken for the Anemic and adolescent girls (496 are identified and provided IFA tablets).
- Govt. Supplies are incorporated (IFA and Vitamin “A” are provided – 1251beneficent)
- Uses evidence-based approaches to design strategies



Environment and Climate change

Arunodaya Trust carries is located nearby Jawharnagar where state’s the biggest dump yard is present. It is trust’s strong opinion that the human capacity to show kindness and concern enables to form the basis of environmental protection. The main activities include methods for reducing waste and trash, information about consumption, recycling tips, facts about pollution and its effects on the environment, global warming and workshops on different ecosystems. Wading through filth, flies and smoke has now become a common survival tactic for those living in the suburbs of Kapra,

Keesara and Dammaiguda blocks of the district. Courtesy, the Jawahar Nagar dump yard that hosts the entire city's refuse. Leachate flows into the residential areas during rainy season. 350 acres of land filling of Jawaharnagar by industrial dumps and wastes is observed. 60 meters height the garbage piled. 12 million tons garbage piled. 4500 tonnes dumped every day. Total aerial extent is 41.68 Km² effected

The Activities carried out with respect to Environment and climate change

72 Awareness campaigns are carried in all the schools (54 in number) and colleges (18 in number)

Targeted 10000 students and Reached 100000 people

Arunodaya Trust worked with prisoners to initiate and improve organic farming and natural pest control management in the biggest Central Jail of State, Cherlapally Central Prison.

117 Performing arts, Kalajathas, street plays and folk dances are conducted in the communities to encourage people's participation. By dint of people's participation, remedial actions are carried out by the Govt. Officials and pollution control board (PCB) to reduce the affects dump yard.

6 Advocacy campaigns are carried to prevent or reduce pollution, restoring the environment after it has been polluted, protecting the economy from a deteriorated environment, recycling, conservation and resource management.

Greater Municipal Hyderabad Corporation (GHMC) ready to give the land as assigned form to implement the developmental programs including safe environmental. development. Opinion leaders & higher officials of Forests, education, PCB and Justice have shown willingness to assist the programs of anti pollutions and safe environment hand in hand.

Every year 1500 Soil made Ganesh idols are given to devotees or communities to avoid colored Ganesh idols to protect environment

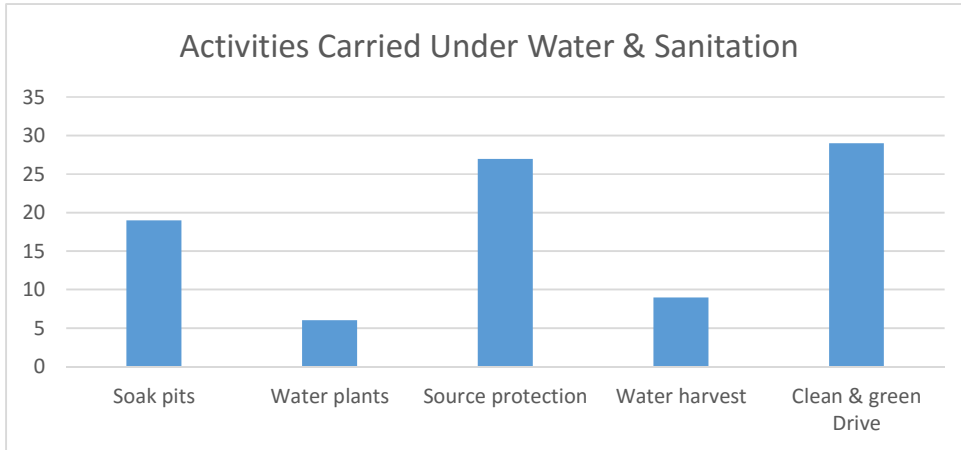
Water and Sanitation

Arunodaya Trust has provided direct technical support and Guidance in construction of Soak – Pits and Water Harvesting Structures. It Built Safe Water Plants at Child care centers and constructed a good number Source Protection Structures. It carried research and developmental programs in the areas of Water and Sanitation, Garbage and Waste Management and finally Safe excreta Disposals. Research and Developmental Programs means low cost constructions, People's Participation and Locally available Resource Management. Arunodaya Trust is vanguard for best practices for possible replication and act as the frontline agency.

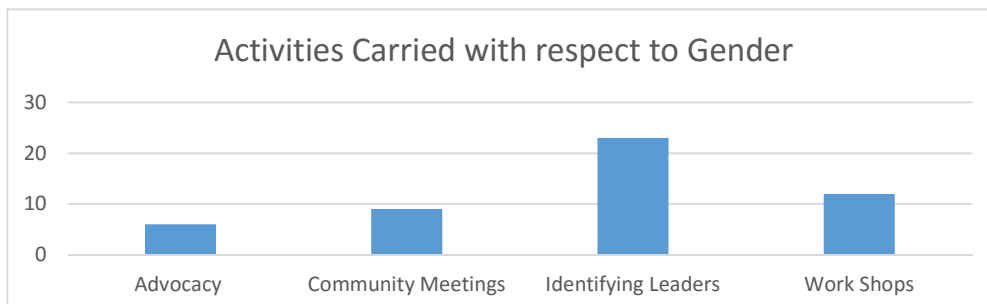
Gender

The Organization has initiated programs to enhance women's health, financial status, education, and political involvement. The organization striving arduously to eliminate asocial practices like gender biased sex selection, deep seated patriarchal mindsets for son preference, technological misuse. The Organization has ensured justice and robust public services to help women that in turn led positive responses to question cultural mindsets and the effectiveness of the legal status to protect women.

Arunodaya Trust gives an emphasis on leveraging of available resources to ensure fulfillment of human rights at the local level, mobilizing communities to claim entitlements from the government, recognizing that the government holds the statutory power and duty to care for citizens, especially the most disadvantaged. In such processes aimed to influence local governance agendas to serve children and women's needs, **Arunodaya Trust** acts as a facilitator, rather than a mere implementer. Strengthening governance mechanisms to build Child and Woman Friendly Communities is Arunodaya Trust's core which facilitates an approach to ensure Child's fundamental rights are fully respected, protected and fulfilled within the family and community where the child grows up in right path.

The Activities carried with respect to above said Areas are

Each sector is envisioned as a separate entity and it constitutes a multifarious approach with definite.

1. Training and Capacity Building (out Of Campuses and in Campuses)

Arunodaya Trust has given trainings to School teachers, Health servants, Project implementing Staff, Monitoring and Evaluation Executives, Management skills for Project or Program middle level Executives, Researchers and executives working in the field of Social Development. Nearly 18 trainings carried at different levels.



Training has carried out for Civil Societies and line staff belonging to Dept. of Health, Dept. of Women and Child Development, Dept. of Rural Water Supply, Dept. of Education and DRDA. Approximately 12 trainings carried past years.

Capacity building exercises have been carried for

Community Based Organizations, neighborhood Leaders, Dais, Self Help Groups, Water and mothers' Committees and elected leaders. At around 27 trainings carried out for communities.



2. Need based Project Implementation

Arunodaya Trust conducts surveys and Action Research Activities before implementing a project. Situational and obligatory analysis carried to design key indicators and base line monitoring factors effectively. The organization could justify the impact and after effect process by analysis of before project implementation and after Project Implementation successfully. Around 12



projects carried and under the process during 2015 – 16.

3. Formation of registered Thrift Societies and facilitating Smooth functioning

The members of the MACS who got benefit for Agricultural purposes are 4258, for Animal husbandry purpose are 3500, for Business purpose are 2416, for personal purpose (includes child's Education) are 1836. The remaining persons availed the loans for the purpose of child's Education. In 2013 Calendar year, the disbursed amount is Rs: 73071000/Euros: 1217850 and received as a recovery from the MACS Rs: 67326745/Euros: 1122112 and the rotation capital is 92%

At the end of December 2016, monthly recovery percentage is 67% and Cumulative recovery percentage is 93%. **Arunodaya Trust** could mobilize internal savings in the ratio of 48:52

4. Establishing Schools for poor especially remote areas

Established 36 High schools in Andhra Pradesh and Orissa States to cater education to poor and remote dwellers especially Scheduled tribes and scheduled castes on free. A good number of school going children are given free Boarding and lodging. Well trained teachers are selected and positioned with respective to their subject expertise.

5. Establishing Technical skill development centers and career guidance with job placement

The organization launched Scholarship Program for School Going Child and Youth. **Arunodaya Trust** have provided and supported Scholarship for 450 children (300 girl adolescents and 150 Boys) to persuade higher studies. DB Tech, a significant and extraordinary program designed very carefully to offer demand oriented skill training for youth on both formal and Non-formal basis (677 youth in our nine centers). The organization also initiated a connecting link project so called, Disha center for Career Guidance and Job Placement for the skill learners.

6. Campaign and advocacy activities

Arunodaya Trust initiated and strengthened "People's Action for Rural Awakening – PARA" (Human rights education and awareness about women rights and gender equality given to 21000 children and capacity building exercises are being carried out in 385 schools). The Organization formed Child Safety Net, and working in all the villages of Krishna District in collaboration with the district administration to establish child safety net.

It run Children's Parliament (366 parliaments with 11666 children, Special trainings were given for Health ministers and Education ministers), It is a platform for children to become good, honest and responsible citizens. Promotion of RTE and integration of Civil Societies

7. Development of Soft ware (IEC and Campaigns) and Hard ware (Structures and tools)

Developed IEC materials by collaborating with Govt. and Dist Administrations, it provided hard ware skill developments and low cost models in Soak Pits, Water Harvesting Structures, ISLs, Source Protections and Safe water establishments. These activities are implemented (around 1000 structures) in Tsunami Affected areas and Nava Jeevan Centers.

Arunodaya Trust designs innovative, effective and low-cost hard ware as well soft ware solutions that are breaking down barriers to high-quality social Development for the world's most vulnerable populations.

8. Communication development and Dissemination strategies

Arunodaya Trust is good at using its global presence and technical leadership to develop technology-based innovations and system management for significant Communication and Documentation impact. It uses Qualitative and Quantitative techniques in providing deliberative shrewd comments for universal acceptance of communicative strategies that were developed by the Organization.



Had been expert in communications, it designed several documentations for a good number of donors and the implemented projects as lessons learnt and human face approaches. It engaged in directing audio visuals, studies, newsletters and websites

.

9. Research and Consultancy.

The interventions and implications have been turned into Policy makings in various organizations (BHEL, Help age, UNICEF, ILO, Alliance India, WFO and Min Agriculture and Min of Labor New Delhi). The organization carried 9 evaluation studies and project appraisals. **Arunodaya Trust** also have a research arm that takes up action researches and other field based trials to check out innovations and their potential to positive influence on policy. Our ideology revolves around building sustainable models within the social sector that deliver critical services efficiently and equitably to undeserved communities. Arunodaya Trust is committed to improving the developmental aspects like BCCP, KAP and change factors of disadvantaged populations by conducting collaborative, inter-disciplinary research on high-priority health problems. The organization has setup demographic, development, environmental, child care, thrift management and health surveillance data. It has conducted 15 research studies on various societal Developments.

10. Rehabilitation and Resettlement

Arunodaya Trust has started practical approach on establishing (Arunodaya Home & Saket Home) protective measures in areas where vulnerable children would gather in large numbers, such as the

platforms. Arunodaya Trust has provided day and night shelter, sick bay facilities, education and all round services, while seeking family reunification, especially through a dedicated staff. The consoling and counseling process helps the organization to track, rescue, convince and restore missing and run away children.

Nava Jeevan supports the parents of street Children and Run away children to develop entrepreneurial skills. (Nava Jeevan means New Life - is a centre for street children and child Laborers. It provides services (By counseling, by guiding and capacity building) for the parents and elderly youth. Around 20000 street children are beneficiaries.

Bridge school: around 150 villages covered under Bridge School. 126 Bridge Schools established with free tuitions provided in four districts and mainstreamed 5500 children

11. Project Management with planning, distinct designing, effective implications and coordinated control.

Arunodaya Trust has implemented around 26 projects during past three years. The projects implemented with great Social Accountability and transparency. Most of the projects are community owned projects and still running successfully. The organization works to improve the health and well-being of people in the poorest communities of the Arunodaya Trust. We do this by sharing our expertise in Socio – Economical – Cultural development and transforming the quality of health care.



12. Policy making

The interventions and implications have been turned into Policy makings in various organizations. The aim of **Arunodaya Trust** is to improve understanding of the causes and consequences of various causal factors of poverty and development to examine how policies affect children and women’s well-being, in order to inform the development and implementation of policy and practice the organization puts enormous efforts to form positive policies. The role of policies in children and women’s lives and its impacts on their life trajectories has emerged as a core theme, and a major focus for data collection and analysis. We promote gender equity, advocate for sound practices and policies, and inspire people to assert their rights to better, healthier lives.
